SECTION 4: First-Aid Measures

If inhaled

SECTION 6: Accidental Release Measures

Personal precautions, protective equipment, and emergency procedures

Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Keep out of low areas. Wear appropriate protective equipment and clothing during cleanup. Methods and material for containment and cleaning up

Following product recovery, flush area with water to remove residual contamination. Dilute acid with water and neutralize with dilute base.
