SECTION 4: First-Aid Measures

If inhaled

Remove individual to fresh air. Seek medical attention if breathing becomes difficult or if respiratory irritation develops. Give oxygen or artificial respiration if needed.

Most important symptoms and effects, both acute and delayed

Direct skin or eye contact may cause corrosive burns. Symptoms may include pain, redness or swelling. Scarring or permanent damage, including blindness, could result. Inhalation may cause severe respiratory irritation, such as coughing and wheezing. Inhalation could result in pulmonary edema, symptoms—chest pain, shortness of breath—may be delayed. Ingestion may produce burns to the lips, oral cavity, upper airway, esophagus, and possibly the digestive tract. Symptoms may include abdominal pain, vomiting, burns, perforations, and bleeding. SECTION 6: Accidental Release Measures
