SECTION 4: First-Aid Measures

Remove individual to fresh air. Seek medical attention if breathing becomes difficult or if respiratory irritation develops. Give oxygen or artificial respiration if needed.

SECTION 6: Accidental Release Measures

Personal precautions, protective equipment, and emergency procedures

Methods and material for containment and cleaning up

Absorb in vermiculite, dry sand or earth, and place into containers. Prevent entry into waterways, sewers, basements, or confined areas. Following product recovery, flush area with water to remove residual contamination. Dilute acid with water and neutralize with dilute base. If not recoverable, dilute with water or flush to holding area and neutralize. Never return spills to original containers for reuse. Contaminated absorbent material may pose the same hazards as the spilled product. In the event of a spill or accidental release, notify relevant authorities in accordance with all applicable regulations.
